Bookings

Terms and Conditions.

Concert bookings are accepted on the following terms and conditions.

1. Bookings are only confirmed once a 50% deposit has been paid.
2. Should cancellation of the booking take place less than thirty (30) days prior to the event the deposit shall be non-refundable.
3. The balance of the fee becomes payable on the day of the concert.
4. Concert start time must be agreed at the time of booking and may not be earlier than 20:00 on a Friday unless it is a Public Holiday. Start times for concerts on Saturday and Sunday evenings may be earlier but must be by agreement with the Choir Committee.
5. The Choir will warm up and do sound checks until 30 Minutes before the start of the concert. During this time the audience will not be allowed into the venue. The organisers will be advised of the time at which the Choir will require access to the venue in order to start the warm up process.
6. The organisers are to provide secure parking for the members of the Choir
7. Although this is not mandatory, it would be appreciated if the organisers could provide light refreshments plus tea, coffee or cold drinks for the choir members during the interval.
8. The Choir reserves the right to market its C.D. recordings and its programme at the concert. The organiser should provide a table for the Choir
